# St. James' Episcopal Church Vestry Meeting (Hybrid) May 27, 2025

**Present:** The Rev. Pilar Padron Parnell, Senior Warden Doug Smith, Junior Warden John Devins, Marie Hughes, Carol Murphy, Judy Holmes, David O'Neill, Kathy Ploufe, Beckie Hidy, John Buterbaugh and Tara Covert.

6:00 PM: Call to Order

**Opening Prayer:** Bishop DeDe Duncan-Probe offered the opening prayer.

An agenda was sent out to the Vestry, prior to the meeting, with supporting documents.

**Rectory Update:** Junior Warden John Devins reported on the status of the insurance claim, housing for the Parnell family and moving forward with repairs.

- 1. The Parnell's are in temporary housing, at this present time, but a long-term rental contact has been signed for September to January 2026. This is being paid for through the insurance claim.
- 2. MCE estimate for total repairs to the Rectory is \$225,220.96.
- 3. Church Insurance Assessment:

- 4. There is a \$75,000.00 difference in the estimate and the amount Church Insurance is providing for repairs. There is a dispute between the Church Insurance structural engineer inspector and the structural engineer hired by St. James' concerning the extent of asbestos removal and the structural status of the home once tear down begins. Abatement costs that St. James' would have to pay are: Expert Environmental and Construction (Removal of Dry Wall/Asbestos:\$32,495.00 and AEG Environmental Group (Air Quality Control during removal)-\$5197.50.
- 5. Through discussion with Martha Berry, Canon Megan Castellan and the Vestry, there are three options for the Vestry to consider regarding the \$75,000.00 difference.
  - a. Submit request to Church Insurance to reconsider estimate based on new information.
  - b. Hire a Public Adjustor to mediate.
  - c. Draw the &75,000.00 from the Hazel Smith Sleeve.

- 6. The Vestry will move forward with making a decision on the options by reviewing our insurance policy, structural reports, contractor's estimate and obtain more information on public adjustors.
- 7. At the end of the discussion Bishop DeDe Duncan-Probe ensured the Vestry that the Diocese fully supported St. James'. She stated her experiences with Church Insurance were very positive and expected that St. James' would have the same positive experience. Martha Berry felt that Church Insurance would support St. James' if further damage was discovered during the restoration project.

1. **April Minutes:** The Vestry reviewed the minutes and no errors were found. <u>John Buterbaugh made a motion to approve the minutes as presented; Beckie Hidy seconded; Vestry approved.</u>
